1. Executive Summary

As an update of deliverable D3.3.1, this document describes the progress made regarding the legal and licensing agreements linked to the sharing of the SAVAS results.

Section 2 details the licensing foundations settled down for data sharing. In Section 3, the questionnaire arranged to collect legal data and identify the licensing schema for each sharable SAVAS language resource is described. Finally, Section 4 presents the agreements reached.

2. Licensing foundations for data sharing

In the framework of the project, a legal expert was appointed with the specific goal of giving support in the definition and negotiation of IPR rights and licensing schemes to the SAVAS partners and data owners.

After investigating the wide range of existing licensing model schemes for data sharing, the legal expert recommended the adoption of the META-SHARE and Creative Commons (CC) schemes shown in Figures 1 and 2.

The first is a set ready to use commercial licenses pre-defined within the framework of META-SHARE by a team of legal experts to foster the needs of the Language Technologies community; the licenses are perpetual, worldwide, easily adoptable and well documented and are recommended by META-SHARE when licensing commercially to non META-SHARE members. By adopting these pre-set templates the owner (or in our case the SAVAS consortium) is spared the trouble of having to write a commercial agreement that fits his/her needs; thanks to the overview Scheme¹, simple questions help identify the desired combination and the text of the agreement can be downloaded and filled.

The second set, also recommended by META-SHARE, represents the best known and best documented scheme for open licensing, when sharing knowledge and creativity for non-commercial purposes. In this case too, accessible documentation and pre-defined templates make licensing to third parties straightforward.

The next step was to identify the most suitable set of licenses among them which could satisfy the SAVAS interests. In order to choose the most adequate licensing schemes, face to face meetings and discussions were held with each partner. In the end, the following three licenses were identified:

- the **META-SHARE Commercial NoReDistribution For-a-Fee** license² (C-NoReD-FF), for commercial purposes
- the **META-SHARE NonCommercial NoReDistribution For-a-Fee** license³ (NC-NoReD-FF), for R&D purposes

- and the **Creative Commons Attribution NonCommercial NoDerivs** license⁴ (CC BY NC SA), also for R&D purposes

In a nutshell, language resources with the C-NoReD-FF licensing schema cannot be redistributed, require the payment of a fee and allow derivatives which can be used for commercial purposes. The NC-NoReD-FF license does not allow redistribution, also requires the payment of a fee and its derivatives can only be used for non-commercial purposes. Finally, resources with CC BY NC SA schemes cannot be redistributed either, require attribution, are free and allow derivatives which can only be used for non-commercial purposes and need to be shared under the same terms.

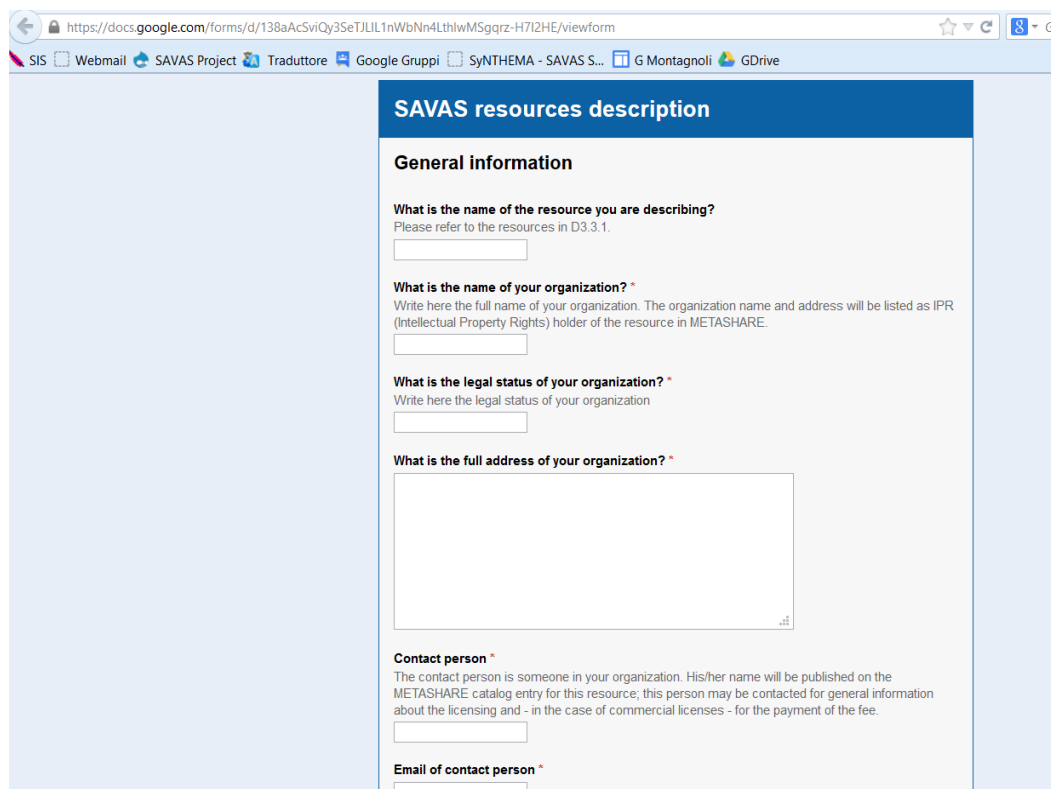

3. Legal and licensing questionnaire

In order to clean the legal status and identify the licensing scheme per sharable language resource, a questionnaire was designed and made available online as a [Google form](https://docs.google.com/forms/d/138aAcSviQy3SeTJLIL1nWbNn4LthlwMSgqrz-H7I2HE/viewform)⁵ to be filled by the SAVAS data providers for each of their owned data sets with the support of the legal expert. Figure 3 shows the initial page of the online questionnaire. The full set of questions can be found in Annex I. Answers to the questions were then used to identify the conditions and purposes under which the resources should be made available.

4. Data sharing agreements

Tables 1 and 2 list the legal and licensing agreements reached for each sharable SAVAS resource, per language.

As it can be seen in the table, the collection of legal data and the identification of the most adequate licenses for the resources owned by the data providers in the consortium has been achieved. The legal status has been cleared for almost all results owned by the SAVAS partners. Regarding licensing, a general consensus has been found on the following principles:

- Resources will be made available to any interested party (also to non META-SHARE members)
- Resource Attribution will be required
- Derivatives will be allowed
- "Share alike" licenses will be used for derivatives
- Commercial and Research licenses will be provided
- A fee will be charged for Commercial licenses
- Research licenses will be provided for free/for-a-fee

The only remaining discussion still ongoing within the consortium is linked to the level of restriction of the transcribed audio datasets for research purposes. While some partners are willing to share them for free and allow derivative works, others are concerned this may have a negative impact in the long term at exploitation level.

The consortium is aware of several potential competitors which are backed up by research centers who could easily get hold of the transcribed audio datasets and use them to improve the commercial systems of their partners, bringing to the market similar transcription and dictation systems as those developed within the project. More restrictive license schemes are being considered to avoid this, while allowing their use as evaluation benchmarks

The legal and licensing status of the resources owned by third-parties is still under discussion. Negotiations have been launched for those resources owned by third-parties (such as French audio or German crawled texts) and the corresponding licensing schemes are under discussion. We plan to advance these discussions during the next few months and expect to close legal and licensing negotiations for all the SAVAS resources before their distribution through the SAVAS META-SHARE repository, forecasted to be made available by the end of April 2014.

5. Conclusions

This deliverable has reported the progress made in the legal and licensing agreements related to the sharing of the SAVAS language resources.

Advancements have been achieved leveraging on face to face discussions and negotiations with each result owner within the consortium. The designed Legal and Licensing Questionnaire has resulted to be a useful tool to collect the specific legal information and identify the most adequate license scheme per sharable language resource.

While the legal status and license types of almost all language resources owned by the SAVAS consortium has been cleared and defined, discussions and negotiations are still ongoing to agree on: (a) the most adequate license scheme of transcribed audio datasets for research purposes and (b) the legal and licensing status of the resources owned by third-parties external to the consortium.

The pending discussions are expected to be closed before launching the SAVAS META-SHARE repository by the end of April 2014.

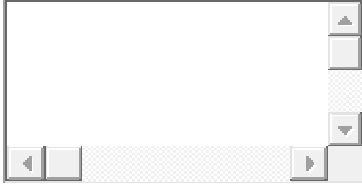
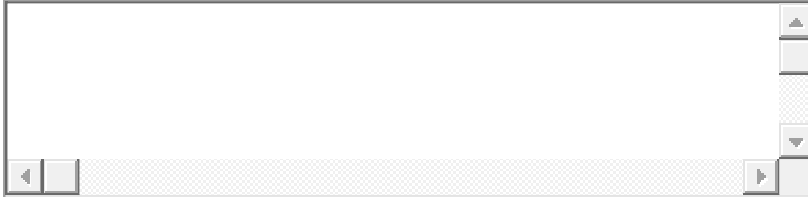
