### 3 Follow-up of the publication strategy

In Deliverable 7.4 we presented our plans for future publications. We aimed to publish papers in peer-reviewed journals about i) multi-level governance of integration, ii) institutionalism and local integration policies, iii) concept and architecture, iv) social and technical perspectives towards technology, and v) ethical issues and informed content. At this time publications have been published, or are in the process of being published, on topics i, iii and v.

In Deliverable 7.4 we also told that we intended to use the data produced by the tool to publish additional publications for the topics of i) diaspora and social media, ii) social media and research methodologies, and iii) integration issues on local aspects. So far, these papers have not been worked on because of that the tool has not yet come to the stage where it is possible to extract data.
