1 Introduction

The present document works is a result of the work done by the SEACW partners who have a presence in Pilots. Within this document a summary and description of activities for contacting entities that will participate in pilots, list of groups (levels 1 and 2) by the consortium to this point is provided and, in addition, list of materials given to Allied Entities and users.

Not only the products and services ready to be tested, but the arranging process of such an ambitious pilot phase for the next 4/5 months is described among the following pages.

This document was scheduled for delivering the ultimate data regarding the pilot phase. Hereby, it includes the final list of products and services which will be ready to be tested within the pilot phase, which are the supportive materials, the definitive dates, and both the allied/collaborating entities and their responsible for managing the final users' experience.

2 Dates

The Pilot Phase is scheduled in the upcoming months of June, July, September, October and November. Some difficulties regarding the summer holydays period were foreseen for the month of August. Thus, the pilot phase will stop during August, and it will be continued through September and November. The arranging process of courses and sessions with the collaborating and allied entities has been scheduled with regard to this holydays issue.

Concerning the deadline of November, it was agreed with the Project Officer and Reviewers during the last Interim Review in Brussels held past month of 15th March 2014.

The Project follows its scheduled steps, with its contents ready to be tested in the upcoming pilot phase. The arranging of this phase has been particularly tough, due to the ambitious number of users to be reached and the integration of contents into the Ecosystem, including translations. The partnership has put the effort on contacting and arranging the sessions with different institutions and public/private companies during last months and continues including new entities willing to participate in the project. Those efforts where transmitted to the European Commission in Brussels during the last Interim Review Hold the past 12th of March of 2014.

3 List of participants

Lists of allied and collaborating entities willing to participate in SEACW's pilots, have been shared with the Project Officer and his team during the lasts months of the project. However, the consortium has kept making efforts for gathering new institutions, companies and foundations to join the project and allow us to reach the figure of 15.000 users or even surpass it. As the EC requested, the minutes of the meetings held by each partner and their potential collaborating entities, including list of participants, was a work expected to be delivered within this deliverable, so that information is re-included in this document along its Annex. As defined in DoW, each partner's Level 1 responsibles are to show the functionalities and solve any possible problems regarding the Ecosystem experience.

The Levels organization is detailed within each partner's Local Support documents.







4 Didactic materials

As shown in Deliverable 4.3, SEACW consortium has developed up to 20 courses composed by different modules and organized within 3 spheres; *Active and Healthy Ageing, Social Inclusion* and *ICTs* (Information and Communication Technologies). The images showed below are screenshots of the Official Catalogue that has been distributed among our allied/collaborating entities:

Putting all the modules together, we get a total amount of 50 modules. Every module will be available in English for the Pilot Phase, whereas 7 modules will be ready in each country's language. The selection of those 7 modules was decided throughout a voting process among the partners, taking into consideration the demands of Allied Entities. For this process, each partner had contacted their potential collaborating entities, getting to know in which particular module those institutions would be interested. Having gathered that information, the partners rated each module, so that the best rated 7 modules (hereby, those more interesting for the entities willing to participate in the pilots) are:

The courses were developed by different partners, depending on their expertise. The entire process was leaded and controlled by Áliad, both as coordinator of the project and Work Package 4 leader. Each course has been developed always with regard to the information gathered in previous steps and delivered documents, with the supervision of our consulting bodies. What follows summarizes the documents and bodies accounted for the development of the courses and the contents of the Ecosystem:

- State of the Art Report. A 141 pages report in which different existing software was analysed for getting to know the best choice for SEACW products and services. In a different level, different digital ecosystems and websites sharing the purposes of SEACW were analysed for detecting its needs and virtues, analysis in which the design of the Ecosystem and its features was based.
- Deliverable 2.3 Final documents of skills and competences for elderly people and social inclusion agents. A detailed description of the skills needed by the social inclusion agents, the elders, and significant users of the Ecosystem.
- Advisory Council consulting. Regular consultation with the members of the body. Physical meetings took place in the cases needed.
- Experts Committee consulting. Regular consultation with the members of the body. Physical meetings were maintained in the cases needed.
- Delphi Survey of Experts. Delphi survey maintained with 80 experts of different fields (ICTs, social/digital inclusion, doctors, sociologists, professors, nutritionists, etc.) in which they were asked for they opinion on basic issues for the project. For instance, they were asked for the type of service the future health-monitoring applications should provide. Their answer has already provided interesting outcomes to taken into account by the SEACW application and course developers.

As it is known, not only courses have been developed by SEACW consortium. The contents have been developed towards the creation of applications, and other resources:

1. Applications. A set of 12 web and mobile applications have been developed to this point of the project. The applications, to be piloted (and therefore tested) among different type of users, depend on the creation of knowledge produced the consortium with the support of its experts and its Advisory Council.







2. SEACW resources. Beyond training activities and applications, the Ecosystem has a wide range of features also depending on contents. News, events, tips, videos, interesting links and many other features have been developed in the following areas:




Figure 1. Set of categories and subcategories within the Ecosystem

7.1 Work done in Spain by Áliad

7.1.2 Work done during the last semester

9.1 Work done by EXOR

The Maltese entities working in the area of elderly and active aging are primarily divided in three areas

- a. Government owned fully by the Government and/or Governmental organisation;
- b. Private owned by private entities major player is the Vassallo Group;
- c. Church fully owned by the Church authorities in Malta;

Meetings have been held with the Government and Vassallo Group who provide care for more than 80% of the elderly in elderly homes. For the Government Dr. Charmaine Gauci attended the meeting. Dr. Gauci is the Director of the Health Promotion Unit and support for such projects and their promotion within the Government entities fall within her duties. For the Vassallo Group, Mr. Nazzareno Vassallo, the owner of the group, attended the meeting.

The meeting with Dr. Gauci was held on the 12th of July 2013 and lasted about one and a half hours. During the meeting, the project was introduced by Mr. Dimech, the managing director of EXOR Group Ltd. The meeting also covered ideas about the platform and the apps that will be developed.
