1 Introduction

1.1 Background

The aim of the Ageing Well Network is to build and animate a European network focused on improving the quality of life of older persons by promoting the market uptake of ICT solutions for Ageing well.

To achieve its aim, the following five main objectives of the Ageing Well project are:

- Develop guidelines for deployment and sharing of best practice between key competence centres;
- Build an ICT for Ageing Knowledge Centre with the aim to share the results with the Ageing Well Community;
- Develop an ICT for Ageing Society Strategic Agenda, with the aim of providing a study on options for future structure and implementation of EU innovation funding;
- Promote the European innovation reinforcement between innovative ICT industries & Ageing (in particular SMEs) and Venture Capital firms, Business Angels and other;
- Raise awareness within the European community of ICT & Ageing stakeholders through webbased communication, and the organisation of 3 international events and 11 national events.

1.2 Summary

This document presents a list of key stakeholders identified by the **Ageing** *Well* network, at Regional, National, European and Global Level identified in these 36 months of activity of the network. Key Stakeholders

In this section, the process of identification and classification of stakeholder's organisations followed by the AgeingWell members is explained. Then, the identified stakeholders are listed and a short description of each organisation is presented.

A tailored template for describing the identified stakeholders has been created and is in use by all founding members. This template allows collecting the information in a similar format and, by this, facilitates the production of the present deliverable.

The identification of relevant stakeholders is performed by all founding members since the beginning of the project and result from their professional activities and networking. Also the organisation and participation in events related to ICT for Ageing contribute to establish new contacts with these stakeholders and to collect information about them. The use of social media platforms and the release of the AgeingWell Newsletter contributed also to gather the interest of actors in this field that contacted the network for further information or to join it, and therefore new stakeholders are identified.

Initial search for relevant stakeholders was made in founding member's countries and then enlarged to other European countries and beyond. From an initial list of six categories (Industry; User organisation; Public authority; Investor; Housing and Insurance; and ICT solutions provider), founding members have decided to reformulate this list of categories according to feedback received from some stakeholders and also as a way of enhancing the usefulness of this document to potential users. In this sense, the identified stakeholders are now distributed in five categories: ICT SME & Industry; Investor; Public Authority; End-users organisation; and Other organisation (Universities, Research Centers, R&D institutions, Insurance companies, etc).

The classification of the stakeholder into a given category has into consideration the main activity of the identified stakeholder. Those stakeholders that joined the network indicate in the application form to which category they belong to.

2.3 Stakeholders Profile




Figure 1 – Stakeholders per Category

In total, 335 stakeholders were identified by the members of the **Ageing** *Well* network during the 36 months of activity of the network. When analyzing the organisations listed above by category (Figure 1), it is possible to observe that the majority of the identified stakeholders are **Other Organisations** (36%), which include many <u>research centers</u>, and **End-users Organisations** (23%) representatives.




Figure 2 – Stakeholders per Country

Concerning location (Figure 2), the majority of stakeholders identified at this stage are located in Spain (15%), Portugal (13%), Poland and Romania (both with 10%).
