## Statement of originality:

This deliverable contains original unpublished work except where clearly indicated otherwise. Acknowledgement of previously published material and of the work of others has been made through appropriate citation, quotation or both.

This deliverable has been developed all along the life of the AFE-INNOVNET project. As part of the WP3, it was meant to support the mobilisation effort and to inform the overall content of the project.

## Methodology

The information contained in the directory has been gathered through different channels all along the life course of the project in an EXCEL sheet. The starting point was a good knowledge of the relevant stakeholders from the members of the EIP AHA D4 group. Afterwards, the main source of information was desk/Internet research from articles mentioning local and regional good practices, a search based on local and regional division dedicated to seniors, social cohesion, social innovation, and welfare and the presence of elderly councils which suggested that the presence of a partnership between the local authority and the seniors. The Steering group also approached stakeholders met during meetings and events (cf. Dissemination reporting done under WP2), participants of the webinars organised in the framework of the project were also contacted (see D3.6), and finally each Consortium member was invited to inform their own network about the activities and purpose of the project.

Furthermore, thanks to a <u>survey</u> carried out in 2012 related to the European Year for Active Ageing and Solidarity between Generations, those that filled in the survey were added to the directory of LRAs and relevant stakeholders.

#### The content

The directory is divided into three different tabs: cities, regions and relevant stakeholders. The cities and regions were filed per country, which allowed to better provide the list of relevant stakeholders to the Consortium members that would be able to help for the mobilisation, due to the language barrier.

The directory provides a list of cities, regions and relevant stakeholders without disclosing the contact details of the persons, as position can be subject to change but also to avoid disseminating contact data at large scale level. It has been developed on a platform that is available to anyone in order to facilitate the share and use of the information, as well as its update.

## Limits

The directory gives an overview of European stakeholders potentially interested by joining the AFE-INNOVNET network. It is a non-exhaustive list of relevant stakeholders and could not include all the stakeholders contacted and deemed relevant by each Consortium member and their network. Indeed, CEMR member associations were invited to disseminate the information to their own members, but with today's communication channels, it was difficult to keep track of all cities, regions and relevant stakeholders contacted by them and the members of the AFE-INNOVNET network. Moreover, based on a desk and internet research, the language barrier was an issue to take into account when looking for relevant stakeholders, and thus, the collaboration with Consortium members was then very crucial to be aware of what was done in their country.

Finally, it turned out that the work carried out by LRAs and other stakeholders - that we considered as part of age-friendly good practices - was not necessarily named as "age-friendly initiative", as the notion of "age-friendly environment" is quite recent and pretty much part of the European and WHO vocabulary. Therefore, it was another barrier that needed to be taken into account when feeding the directory.
