Recruitment Pack AFE-INNOVNET

1. Foreword

Global population is now undergoing a demographic change that will have repercussions on several issues, such as pensions, health care and long-term care systems. With the support of the European Union ICT Policy Support Programme, the AFE-INNOVNET project is establishing a Thematic Network (TN) of local and regional authorities, industries, research institutes and civil society that share the same ambition: work together to find smart and innovative evidence based solutions to support active and healthy ageing and develop age-friendly environments (AFE) across Europe. Through this network, our members will have access to various data and they will be able to create partnerships with the private sector. Indeed, our network is open not only to local and regional authorities, civil society and universities, but also to the industries – SMEs included. Older people have specific needs and represent a market that should be taken into account to face the demographic challenge and stimulate the economy.

In the long run, our **aim** is that the socioeconomic evidence, methodologies and case studies gathered thanks to the members of the Thematic Network will **benefit** all interested stakeholders and influence the EU agenda on active and healthy ageing.

Being a member of the TN will of course give you access to the information available on AFE-INNOVNET's website (case studies, a directory of local and regional authorities, indicators...) but you will also have the opportunity to **collaborate by providing your input** to the TN's activities, share your experience and knowledge, and be in direct contact with other members of the TN.

2. Background

The European population is rapidly ageing. This transition can be explained by low birth rates, ageing "baby-boomers" and rising life expectancy. According to Eurostat data, between 2010 and 2060, the number of people over 65 will grow from 17.4% to 29.5% (compared to 12.8% in 1985) of the total population and the number of people over 80 will nearly triple to 12%. The **demographic change** Europe is now facing will have significant social, economic and budgetary consequences.

According to WHO, the physical and social environments are key determinants whether people can remain healthy, independent and autonomous long into their old age. Local and regional actors will have to work together to improve conditions, develop and implement new solutions in fields such as employment, health care, social services, housing, IT services and transport, as the economic and social models of the past 50 years may no longer be suitable for the current situation. Local and regional actors are the ones that can better understand and respond to the specific challenges that demographic ageing and other factors pose to their communities.

To address the demographic change, many local-level innovative solutions supporting active and healthy ageing have been developed as pilots across the EU, but they often remain isolated and do not get scaled up, not even in their own country. Therefore, their impact on responding to challenges of demographic change in Europe is limited. To remedy the problem, an EU-level initiative called **European Innovation Partnership on Active and Healthy Ageing** (EIP AHA) was launched by the

European Commission in 2011 to accelerate and scale-up the uptake of innovation with the triple goal of improving the quality of life of older people and their carers; increase the sustainability of care systems; and create new growth and market opportunities for Europe.

The **AFE-INNOVNET** will take the EIP AHA a step further by creating and developing a Thematic network (TN) that will support and enhance the operational implementation of the EIP AHA D4 Action Group's work plan; taking stock of the work done in the D4 Action Group and up scaling working ICT-based solutions.

AFE-INNOVNET will not only build on the experience of WHO age-friendly environments programme but will closely collaborate with WHO and facilitate synergies.

3. Why join?

The project's goal is to set up a large **EU** wide **community** of local and regional authorities and other relevant stakeholders across the EU who want to work together to find **smart and innovative evidence based solutions** to **support active and healthy ageing** and **develop age-friendly environments** across the EU. By joining our Thematic Network, you will:

- ✓ Be able to participate in webinars where concrete themes related to age-friendly environments will be discussed and solutions proposed;

4. Impact

By enabling key local and regional authorities and stakeholders from different levels of governance to link up and join forces, the TN will set up the necessary framework to mobilise and support an EU wide uptake of smart and innovative age-friendly environments solutions which have demonstrated a positive socio-economic impact. It will help local and regional authorities to respond to Europe's demographic challenge by stimulating investment and facilitating the deployment of innovative age-friendly ICT and social solutions to help older people to age in better health and remain active for longer, lowering the pressure on social and healthcare systems and fostering longer working lives. This EU wide mobilisation should also help develop an EU wide single market for innovative ICT based silver economy products and services.

5. Ultimate result

In the long run, a **European Covenant on demographic Change** will be developed through a bottom-up iterative method involving all Thematic Network members which will bring together all committed local and regional authorities and other stakeholders interested to share their experience, pool their efforts together and deploy ICT based innovative age-friendly environments solutions to support active and healthy ageing. The Covenant will seek to create the necessary political and technical framework to bring together local and regional authorities across the EU in a more formal and **long-term structure.**
