Project execution

MMECC Project objectives

The aim of the MMECC project is to extend awareness of the methodology for estimating the costs of crime. Agencies in some member states make significant use of this methodology and incorporate the resulting estimates in the appraisal and evaluation of criminal justice interventions, projects and pilots. But other countries do not as yet have estimates available to use for these purposes and some remain uncertain as to the methodology and raw materials required.

The web site that has been created as the principal output from the project outlines the methodology needed to make cost of crime estimates. It also offers examples to illustrate how the findings can be, and have been, employed to help develop an evidence base documenting the benefits of criminal justice interventions.

The project has a number of objectives, namely:

- to audit the methodology used by member states for estimating the costs of crime
- to audit the application of the resulting estimates in real-world criminal justice policy settings
- to bring together criminal justice policy analysts from member states and academic researchers to share findings about methodology and the application of findings
- to compile a series of resources including data, learning materials and interactive models, for use by policymakers and others wishing to review the methodology for making estimates of the costs of crime
- to explore examples of the application of the estimates
- to develop a means of making the materials widely available
- to disseminate information about the methodology and about the project.

Work performed

During its first year the project built the foundations for a resource that can be used by criminal justice policy analysts and others to estimate the costs of crime by offence type. The materials assembled included a prototype spreadsheet model for cost estimation, outlines of the basic principles of the requisite methodology, a bibliography and commentaries covering topics such as the application of cost estimates to the appraisal and evaluation of criminal justice, programmes, projects or interventions.

During its second year the focus was on the process of harnessing the materials assembled during the first year in the form of a web site. The resulting site lists the major and minor components of the costs of crime. It outlines how each component can be estimated and how these individual estimates can be assembled into a cost of crime number. It provides discussion of more technical issues such as the kinds of statistical data available for all or some member states and how offence types can be classified in a way that facilitates transfer of the methodology to new settings.

Throughout, there was an emphasis on disseminating the approach more widely across the EU. Project participants have given many talks on the subject to a wide range of academic and policy audiences. They have also published many papers in academic and policy papers and reports that make use of the project material.

During 2008 there were opportunities to demonstrate the capabilities of the model both to EC policy makers in Brussels and also to an audience of criminal justice policy makers from across EU member states.

The decision to allow and encourage open access to the site enables the widest possible viewing of the material. The site does not offer ready-made cost estimates for all member states but it does offer practical guidance on how to collect and process the requisite raw data. It outlines a strategy for countries to follow when developing estimates for the first time and contains many examples of how the estimates can be utilised constructively for policy purposes once they have been made.

End results

Methodologies and approaches employed

There is a degree of controversy as to how best to go about estimating the costs of crime. Economists incline instinctively to employ 'top down' methods

based on ascertaining consumer willingness to pay for reductions in crime levels. In practice criminal justice analysts tend to employ 'bottom-up' methods that rely on identifying individual components of the costs incurred by victims and estimating each in turn. The web site refers to both possible approaches but the model it outlines is based on the bottom-up approach used to develop most of the estimates of the costs of crime available on government sites.

The site contains a review of the literature which reviews both approaches, providing a review of theory and practice to date. The largest single section gives a fully disaggregated treatment of cost of crime components. The site also has a section devoted to 'making your own estimates' with advice about how to go about the task of constructing cost of crime estimates. A further section outlines the principal tools for appraising and evaluating criminal justice interventions and projects. It goes through the principal techniques including cost effectiveness analysis and cost benefit analysis and demonstrates how these methods can be and have been used in practice. The site also contains a future development section which offers some speculations about how the methodology might be developed and applied in the future.

Relation of project achievements to the state of the art

The costing model at the heart of the web site is, as far as we can ascertain, the most complete publicly-available tool for estimating the cost of crime. A number of institutes or government departments, including the Australian Institute of Criminology and the Home Office, publish cost of crime estimates. But in neither case is it possible to view the models in worksheet or similar format. Books on the subject are less detailed and less friendly to the analyst setting out to make or apply their own estimates.

Impact on the industry or research sector

There have been many encouraging signs that this has been an applied research project of substantial interest to the criminal justice policy making community. Policy makers have attended a number of the presentations given by project participants. A number of projects are being discussed as a result

of contacts made on these occasions. In addition to pilot work based in Poland there have been discussions with policy makers in Denmark, Hungary and Northern Ireland about the possibility of developing cost of crime estimation projects in those countries. The Co-ordinator has agreed to do a review for the Northern Ireland Office of the Costs of Crime against Government Departments. He has also agree to visit Budapest in September 2009 to investigate the scope for developing cost of crime estimates for Hungary.

2. Dissemination and use

The publishable results of the project take three principal forms. The most accessible and widely used medium has been the project web site, launched in early December 2008. It contains a wide range of resources to inform not only the making of cost of crime estimates but also illustrations of how the resulting estimates can be, and have been, used for purposes of criminal justice policy analysis. The development of the web site has been supported by the large bulk of research efforts contributed by the project participants. The other principal medium through which these efforts will find lasting expression has been publication in books and journals. Many contributions have also been made in the form of presentations at a wide range of academic and policy-focused organisations and conferences.

Overview table

Table 1, at the end of the document, provides a summary of the various types of output from the project. We summarise here briefly each of the principal types of output.

Web site

The web site was developed in two stages. First, an experimental site was built in a Virtual Learning Environment (VLE) for use by project participants as an interactive development tool. The second stage of development involved migrating the material to conventional web format in mid-2008. A final round of revisions was completed before the public launch of the site at the Milan meeting in December 2008.

The objective of the site is to act as a resource centre which criminal justice policy makers throughout the EU, and beyond, will be able to use when developing cost of crime estimates or applying such estimates in policy appraisal or evaluation work. It is envisaged that it will offer extensive linkages not only to the custom-written modules (produced as part of this project) on many aspects of compiling cost of crime estimates but also to a range of external sources covering topics such as appraisal and evaluation guidelines for government projects (both in general and in relation to criminal justice) and criminal victimisation surveys (both domestic and internationally-sponsored). The website is located at: www.costsofcrime.org. The main sections of the site are as follows: theory and practice to date; costing principles and methodology; making your own estimates; policy tools and future development.

The public that we are aiming at includes the general public and academics. But the specific target is Criminal Justice policy makers. We are aiming to ensure that the website has a simple structure which is easy to navigate for users seeking information about the methodology for estimating the costs of crime across the EU. We are expecting to launch the complete website by Summer 2008. We anticipate revising the site in light of feedback from the EU before launching.

¹ An outline of the objectives of the panel follows: “Criminology literature is rich in the evaluations of interventions designed to improve the effectiveness of public safety and crime control programs. Evaluations that demonstrate the effectiveness of certain intervention strategies have rarely been associated with actual commitments of public resources to programs that embrace these strategies however. One explanation for reluctance to change is that evaluations have traditionally ignored issues of the likely return on investment. Potential public funders receive no insights as to the basic resource requirements of the new program relative to the requirements of current programs, nor do they receive information on the relative costs of achieving desired outcomes. This presentation examines some of the challenges that evaluators face when they try to incorporate such information in their research designs and some of the solutions adopted in actual evaluation efforts. It also discusses some of the tradeoffs that should be considered in choosing between evaluating cost-effectiveness and cost-benefits”.

Institute of Criminology, Warsaw

Roger Bowles and Richard Dubourg visited the Institute of Criminology, Warsaw in November 2008 to work with Jacek Czabanski on making cost of crime estimates for Poland. Part of the output from this work was presented at the Milan Symposium in December 2008, and a paper based on the output is to appear in the Special Issue of *European Journal on Criminal Policy and Research*. This work has prompted interest from other parts of the EU. It seems likely (as of January 2009) that a similar kind of visit may be made by Roger Bowles and Richard Dubourg to Hungary to undertake similar work there in due course.
